What are we going to use your data for?

In general, your personal data will be used to relate to you and to provide you with our services.

Likewise, they can also be used for other activities, such as sending advertising or promoting our activities.

Why do we need to use your data?

Your personal data is necessary to be able to relate to you and to be able to provide you with our services. In this sense, we will put at your disposal a series of boxes that will allow you to decide clearly and easily on the use of your personal information.

Who will know the information we ask for?

In general, only the personnel of our entity who are duly authorized will have knowledge of the information we request.

Likewise, entities that need access to it may be aware of your personal information so that we can provide our services to you. For example, our bank will know your data if payment for our services is made by card or bank transfer.

Likewise, those public or private entities in which we are obliged to provide your personal data due to compliance with any law, will have knowledge of your information.

Taking an example, the Tax Law obliges us to provide the Tax Agency with certain information on economic operations that exceed a certain amount.

In the event that, apart from the aforementioned assumptions, we need to disclose your personal information to other entities, we will previously request your permission through clear options that will allow you to decide.

How are we going to protect your data?

We will protect your data with effective security measures based on the risks associated with the use of your information.

For this, our entity has approved a Data Protection Policy and annual controls and audits are carried out to verify that your personal data is safe at all times.

Will we send your data to other countries?

In the world there are countries that are safe for your data and others that are not so safe. For example, the European Union is a secure environment for your data. Our policy is not to send your personal information to any country that is not safe from the point of view of protecting your data.

In the event that, in order to provide the service, it is essential to send your data to a country that is not as safe as Spain, we will always request your permission in advance and apply effective security measures that reduce the risks of sending your personal information to another country.

How long are we going to keep your data?

We will keep your data for the duration of our relationship and as long as we are required by law. Once the applied legal deadlines have ended, we will proceed to eliminate them in a safe and environmentally friendly manner.

What are your data protection rights?

At any time you can contact us to find out what information we have about you, rectify it if it is incorrect and delete it once our relationship ends, if this is legally possible.

You also have the right to request the transfer of your information to another entity. This right is called "portability" and can be useful in certain situations.

To request any of these rights, you must make a written request to our address, along with a photocopy of your ID, in order to identify you.

In the offices of our entity we have specific forms to request these rights and we offer our help to complete them.

Can you withdraw your consent if you change your mind later on?

You can withdraw your consent if you change your mind about the use of your data at any time. Thus, for example, if you were interested in receiving advertising for our products or services in your day, but you no longer wish to receive further advertising, you can notify us through the opposition form to the treatment available in the offices of our entity.

If you understand that your rights have been neglected, where can you make a claim?

If you think that your rights have been neglected by our entity, you can make a claim at the Spanish Agency for Data Protection, through any of the following means:

Filing a claim at the Spanish Data Protection Agency does not entail any cost and the assistance of a lawyer or attorney is not necessary.

Will we create profiles about you?

Our policy is not to create profiles on the users of our services. However, there may be situations in which, for the purpose of providing the service, commercial or otherwise, we need to prepare profiles of information about you. An example could be the use of your purchase or service history to be able to offer you products or services adapted to your tastes or needs.

In such case, we will apply effective security measures that protect your information at all times from unauthorized persons who intend to use it for their own benefit.

Will we use your data for other purposes?

Our policy is not to use your data for purposes other than those that we have explained to you. If, however, we need to use your data for different activities, we will always ask for your permission in advance through clear options that will allow you to decide for yourself.

In accordance with the **Federal Law on Protection of Personal Data** held by individuals (here in after referred to as "the Law"), we allow ourselves to carefully read the terms and conditions contained in this document, since the simple contribution that you make of your personal data or sensitive data constitutes acceptance of these terms and conditions:

I. MIMPO GLOBAL LOGISTIC MEXICO AND ITS COMPANIES, with address at Av. Independencia # 778, Col. Centro, C.P. 91700, Veracruz, Ver. Mex. is responsible for collecting your personal data in this act and future, as well as the use that is given to them and their protection.

The area responsible for the handling of your data is committed to the protection of all those Personal Data provided by the owner.

II. The personal data and / or sensitive data that you can provide to the person in charge will be used by way of example but not limitation to identify, locate, communicate, contact you, send you information and / or merchandise, as well as its transmission to third parties by any means that allows the law.

The use of personal data and sensitive data will be directly related to the type of relationship that you have in your capacity as; candidate for some position, employee in the company or some subsidiary, supplier, customer, distributor, etc. The temporality of the handling of personal data and / or sensitive data will be indefinite from the date you provided them to the person in charge, who of course you can oppose at any time you consider appropriate.

If you do not express your opposition, it will be understood that you have given your consent.

III. Once you hand over your personal data or sensitive data to the controller, we declare that these will be kept in different secure media that technology allows, whose access will be limited only to individuals and / or legal entities with whom the controller has any relationship. legal.

The person in charge will have the security measures it deems appropriate to protect the use of your personal data and / or sensitive data by unauthorized third parties. In case of requirement of any authority, personal data and / or sensitive data may be made available to them, in strict compliance with the Law. Our databases are protected by firewalls and focused computer and / or computer systems. to prevent and avoid that people outside **MIMPO GLOBAL LOGISTIC MEXICO AND ITS COMPANIES**, or unauthorized, can access your personal data.

IV. At any time you may have access, rectify, cancel, oppose and / or revoke the consent that you have given us for the treatment of your personal data, so that we stop using them, sending an email to avisodeprivacidad@mimpo.com within a maximum period of 45 days will receive confirmation of your request.

V. Your personal data can be transferred and processed inside and outside the country, by people other than MIMPO GLOBAL LOGISTIC MEXICO AND ITS COMPANIES. In this sense, your information may be shared with credit investigation agencies, portfolio recovery agencies, insurers, sureties and / or chambers or trade associations; to carry out analysis and authorizations of credit, collection and market research. If you do not express your opposition, so that your data is transferred, it will be understood that you have granted your tacit consent to do so.

VI. In the event that there are changes in the privacy notice, this company will notify the owner of the data that was provided to us, with a period not exceeding 10 days by email.
